WHY A NEWSLETTER?

In January 2017, the Belmont County Enhanced 911 Board voted unanimously to request that the 911 Board be dissolved, as they felt it no longer served a useful purpose. To address this request, the Belmont County Board of Commissioners called a meeting of the 9-1-1 Planning Committee to discuss changing the 911 Final Plan. On March 22, 2017, the Planning Committee amended, and unanimously approved, the 911 Final Plan and eliminated all language that established the Enhanced 911 Board. The amendments were approved by the Commissioners at their April 5th meeting. As part of the Board being disbanded, 911 Director Bryan Minder agreed to continue communications to all public safety and governmental agencies as to any changes or updates with Belmont County 911. Communications will now come to you in the form of a quarterly newsletter, "The 9-1-1 Dispatch". You should expect to receive these newsletters in April, July, October and January of each year.

ANNUAL RADIO AND PAGER INVENTORY

Beginning in late April, Belmont County 911 will begin to send out information to all departments regarding the annual radio and pager inventory. Since all radios were reprogrammed last spring, this year will just need an inventory completed by the Chief, or designee, of each department. Once completed, the Chief will sign off on the inventory and return the paperwork to Director Minder. Changes should be made on these sheets, prior to submission. Signing the document assures that the inventory is correct and all radios and pagers are accounted for. As always, if there are questions or discrepancies, please be sure to address them with the 911 Director prior to signing off on your inventory.

ACTIVE 911

As a reminder to all Fire and EMS agencies utilizing Active 911, Belmont County 9-1-1 does **NOT** administer the Active 9-1-1 system or its users. We merely fund the annual subscription. The Belmont County Fire & Squad Officer's Association has administrative control of the app for Belmont County. Anyone needing Active 911 access, or needing changes to your Active 911 account, should first contact your Fire Chief. They must approve your access and send a form to the Fire & Squad Officer's Association. The following rules must be followed for access:

- Must be active and certified (or working to be certified) through the State of Ohio in Fire and/or EMS
- 2. No more than two devices on the system per person
- Cadets must be at least 16 years of age, with a letter from the Chief verifying permission to be on the system.
- 4. The Fire Chief will submit a form, or letter, of ALL department members needing access to the app.

MONTHLY CALL NUMBER REPORT

At the end of this newsletter, we will continue to provide you with the monthly call numbers for each department in Belmont County. As a reminder, your numbers may differ from what we report. Our report represents the number of calls that a department is associated with in the CAD. This means if your department was dispatched to a call, but didn't respond, we still show it as one call for your agency. Your department may not have a record of that call, since no one responded.
