#### 2019 CALLS FOR SERVICE

Six months into the year, CAD transactions for the county are slightly down. 25,183 calls have been entered into the CAD, which is down 4% from the same time last year. 9-1-1 calls are up by 10% from last year. Current 9-1-1 calls coming into the center are 18,939. 7-Digit line calls are up over 17% from the same time in 2018, as 46,265 7-Digit calls have been received here.

### **BELMONT COUNTY OVERDOSES REPORTED**

Overdoses reported to 9-1-1 countywide are currently at 85, halfway through 2019. In 2018, we had 52 reported overdoses by the end of June. Monthly breakdown for 2019 is as follows:

#### BELMONT COUNTY RADIO SYSTEM UPGRADES

Bearcom is currently staging and testing the equipment for the Paging and Microwave system upgrades. Staging and testing is a very important part, so that when the equipment is installed, everything is set-up and ready to turn on, giving us very little downtime on our system.

Additionally, Belmont County has been approved for two additional frequencies to use on our 800 MHz P25 Radio System. This will help to increase the capacity of the system, so that during the busiest periods, users will have less "busies" when attempting to communicate. Users currently talk on one of four frequencies. This will increase that to SIX frequencies for communications. This will be put in place later in 2019, or into early 2020, as we work with Motorola to also upgrade the radio system software, at the same time.

The system software has not been updated for 5 years and there have been five new versions released during that time. We anticipate going to version 7.18 in the previously mentioned timeframe. This will allow our system to expand and offer new features, while maintaining compliance with Motorola's annual maintenance program. During this system upgrade, each mobile and portable radio will need to be updated with additional software, so that they may utilize some of the new enhancements.

All of these upgrades will be paid with funds from the 9-1-1 Radio System Upgrade Levy. Without this levy, none of these upgrades and enhancements would be possible.

#### INTEROPERABILITY MEETING HELD

A meeting was held in Ohio County, WV on May 8, 2019. In attendance were representatives from Ohio County (WV), Marshall County (WV), Jefferson County (OH), Belmont County (OH) and Bearcom. Discussions were held as to how we could all better communicate with one another. Sharing of access to radio systems and talkgroups were arranged and plans put in place get each county access to one another. Programming and coordination still must be completed, but in the near future, we should all have the access available to communicate across state and county lines. As this progresses, I will keep everyone updated on the status.
